Braj Planning & Development Board invites Expression of Interest (EOI) from the interested agencies having experience and expertise for providing and operation of Eco-friendly vehicles for City Bus Service under the project brand name **BRAJ VAHINI** in Vrindavan, Distt. Mathura.

Vrindavan is the place of Leelas performed by Lord Krishna and therefore religious tourist area. The lakhs of devotees visit this place every year. The narrow lanes and roads are now insufficient to handle the surge of devotees, specially on holidays and festivals. Majority of devotees visit Vrindavan by their own vehicles or chartered buses. This creates chaos leading to jam.

The Board has proposed to enforce parking of out station vehicles at the parkings developed on the outer side of Vrindavan. From these parking stations the vehicles (A/c. / Non A/c.) with different sitting capacities (8 to 20) are proposed to be run on different routes at regular interval. The transport system has to be developed with a view to give a unique identity to Vrindavan heritage and in turn which will boost tourism of the area.

The work includes traffic survey and in turn requirement of vehicles, their supply, operation and maintenance for systematic and regular operation.

The eligibility criteria for pre-qualification/experience of the agency for EOI will be as under:

- **Management System:** Agency should have necessary infrastructural facilities, managerial skills and necessary man-power. The agency should be registered and with minimum 10 years experience.
- **Technical Capacity:** The agency should have infrastructural facilities like workshops etc. and sufficient man power.
- **Financial Capacity:** The agency must have sound financial position.

Other details:

The role of Braj Planning & Development Board in this exercise is limited only as a facilitator for the information and coordination between different Govt. departments. The Board will have discretion to reject any proposal without giving any reason. The board also reserves the right to change any provisions for qualification of agencies after Pre-Bid Meeting.
